

# 2022 HOUSEHOLD HAZARDOUS WASTE DAYS

**NO ELECTRONICS WILL BE ACCEPTED AT THESE EVENTS\*\***

## **PRE-REGISTRATION REQUIRED FOR ALL PARTICIPANTS!**

We have partnered with the City of Troy and Rensselaer County on joint events to improve efficiency and lower costs for all. There are a limited number of spaces available to pre-registered residents from Bethlehem for each of the 6 events this year.

## **HOW TO REGISTER (if you haven't already):**

- 1) Please choose ONE of the 6 events listed below. Note that locations vary between events.
- 2) Click on the DATE/CITY for that event which is a link, and complete the very short online registration.
- 3) You will receive an email a few days before the event date with more details including directions and an assigned timeslot for your arrival. If you can possibly make that slot it lowers everyone's wait times.

### **ALL EVENTS ARE SATURDAYS, 8 AM TO 2 PM**

**June 11 – Troy:** City of Troy Resource Management Facility/ "the Alamo", 3000 East Industrial Parkway, 12180

**July 30 – Schodack:** Schodack Highway Department, 3776 US Highway 20, 12123

**August 27 – Brunswick:** Brunswick Building Department, 336 Town Office Road, Troy, NY 12180

**October 1 – Bethlehem:** Town of Bethlehem Highway Garage, 74 Elm Ave East, Selkirk, 12158

**October 29 –Troy:** City of Troy Resource Management Facility/ "the Alamo", 3000 East Industrial Parkway, 12180

**November 19 - Poestenkill:** Poestenkill Transfer Station, 9002 NY-66, Averill Park, NY 12018

### **NOTES:**

- Only Pre-registered Town of Bethlehem, Troy, and Rensselaer County residents can participate.
- Keep wastes in their original labeled containers. Tighten lids and pack securely in a cardboard box.
- Never mix chemicals. Wrap leaking containers in newspaper and place in plastic bag or container.
- DO NOT smoke near chemicals or leave product in a hot, unventilated vehicle for an extended period of time.
- For everyone's SAFETY, please stay in your car. Workers will unload the material.
- We reserve the right to refuse any material that is deemed unacceptable by the managing chemist.
- Limit of 30 gallons or 200 lbs of waste per participating pre-registered household, to keep it fair for everyone.

### **ACCEPTABLE WASTES**

- ▲ Pesticides/Herbicides/Insecticides
- ▲ Paints (Oil Base, Latex)
- ▲ Wood Preservatives and Stains
- ▲ Thinners, Solvents & Drain Cleaners
- ▲ Pool Chemicals
- ▲ Gasoline/Kerosene (NO motor oil)
- ▲ Propane Tanks
- ▲ Cleaning Products; Acids and Bases
- ▲ Asbestos (Wet and Double Bagged)
- ▲ Batteries: Rechargeable, lithium, & lead acid/vehicle batteries (NO alkalines)
- ▲ Fluorescent & CFL Light Bulbs
- ▲ Mercury Thermostats & Thermometers

### **UNACCEPTABLE**

- ▼ Empty Paint Cans (remove lid & throw in trash)
- ▼ Empty Aerosols (trash)
- ▼ Explosives/Ammunition
- ▼ Fireworks
- ▼ Radioactive Material
- ▼ Controlled Substances
- ▼ Known Dioxins
- ▼ Compressed Gases
- ▼ Commercial Waste
- ▼ Medical Waste/Medical sharps
